

Webberville Community School's Board of Education
Special Meeting Minutes
December 8, 2005

This Special Meeting of the Webberville Board of Education was called to order by Board President Simmons in the Webberville Board of Education office Thursday, December 8, 2005, at 8:42 p.m.

Present: Clifford H. Simmons II, Teri Chamberlain, Kristine Brenner, Caron Guidroz, Matt Kulaga, Patricia Shanabrook and Kathe Westbrook

Also Present: Dr. William Skilling, Superintendent, Brian Friddle, Principal

Approval of Agenda:

Ms. Shanabrook moved, Mr. Kulaga seconded a motion to approve the Agenda of the Special Board of Education Meeting being held Thursday, December 8, 2005, as presented. Motion passed 7-0.

Dr. Skilling explained the ground rules of the hearing. He answered any questions that were asked about the hearing. He asked the defendant's representatives if they wanted an open or closed meeting. They requested an open meeting.

Public Hearing

Ms. Chamberlain moved, Ms. Shanabrook seconded a motion to approve an Open Public expulsion hearing student 2005-1. Motion passed 7-0.

Dr. Skilling introduced Principal Brian Friddle to present the information regarding this hearing. He provided written information as to the conversations and actions that have taken place that have led up to this expulsion hearing.

Dr. Skilling introduced Student 2005-1 and the parents as the defendant's representatives. The mother, Student 2005-1, step-father, another student and a parent of another student addressed the board with their information as it related to this hearing.

There was a period of questions from board members to both Mr. Friddle and the defendants. The defendants also asked questions of Mr. Friddle. All questions were answered.

Ms. Westbrook asked along with Ms. Guidroz if there was some other way to have this student leave our district without doing the expulsion. Dr. Skilling and Mr. Friddle answered that once this case has been brought to an expulsion hearing a decision to expel must be made.

President Simmons stated that this was a very difficult moment for the board. He asked the board for a motion.

Ms. Brenner moved, Ms. Shanabrook seconded a motion to expel Student 2005-1 as presented. Roll call vote:
