Ms. Guidroz moved, Ms. Brenner seconded a motion to close the Webberville Board of Education Scholarship Fund at Citizens Bank and donate the money to the SSG Gregory McCoy Memorial Fund. Motion passed 7-0.

Ms. Shanabrook moved, Ms. Brenner seconded a motion to approve the agreement with Dr. William Mangan to provide medical services at Webberville Community Schools pending successful contract negotiations. Motion passed 7-0.
