Mr. Smith reported:

- Overnight trips were presented for Boys Varsity Basketball and Cross Country. Cross Country trip denied due to July 4 holiday week.
- Several Building and Grounds expenses are needed and were reviewed. These include parking lot line painting, elementary lift station repair, elementary fire alarm system replacement that failed inspection, concessions building with soffit damage from storm, fence damage from high jump mats during storm, elementary boilers repair, secondary fire alarm system only needing minor repairs and passed inspection, fire extinguishers needing updating, flag poles and flags needing repair.
- The food service excess budget can be used towards replacing grease traps and replacing flooring.
- July 1st contracts will be brought on Monday for approval. Health Care coverage changes were discussed. Will review 1 or 2 employees' contract duties due to hiring of new principal.
- MHSAA Resolution will be actioned on Monday.
- Self-Contained Special Education position is still open.
- Mr. Smith has met with Mr. Troy Perkins and is continuing seeking athletic league membership.
- Mr. Rockey is seeking assistance from outside company on flag pole and flag repair.
- Car wash fundraiser for Drama Department discussed.
