Superintendent's Update

Mr. Smith presented:

-23AA suit still pending. Injunctive relief has been filed and Superintend meetings are taking place this week for more information.

-27L money has flexibility in clarity on which employees are covered. Waiting on disbursement language that affects staff who can be covered and student loan forgiveness programs.

-Resolution needed from the Board for potential products to be purchased from Z Solutions. Recommended following very clear guidance on conflict of interest and would depend upon Board input.

Ms. Rhodes moved, Mr. Rockey seconded a SECOND READING AND ADOPTION OF NON DISCRIMINATION POLICIES: PO1422(REPLACEMENT), PO1422.02(RESCIND), PO1623(TECHNICAL CORRECTION), PO1662(RESCIND), PO2260(TECHNICAL CORRECTION), PO2260.01(TECHNICAL CORRECTION), PO3122(REPLACEMENT), PO3122.02(RESCIND), PO3123(TECHNICAL CORRECTION), PO3362(RESCIND), PO4122(REPLACEMENT), PO4122.02(RESCIND), PO4123(TECHNICAL CORRECTION), PO4362(RESCIND). Roll Call Vote: Lycos – Y; Rhodes – Y; Musolf – Y; Rockey - Y. Motion passed 4-0. Ms. Musolf asked about difference in order of policy numbers compared to the past updates. Mr. Smith explained.

B. Mr. Rockey moved, Rhodes seconded a SECOND READING AND ADOPTION OF FALL BOARD REVIEW POLICIES: PO2210, PO2266, PO2412, PO4162, PO5120, PO5460, PO5517.01, PO7540.02, PO7541(RESCIND), PO8300, PO8305. Roll Call Vote: Lycos – Y; Rhodes – Y; Musolf – Y; Rockey - Y. Motion passed 4-0.

C. Ms. Rhodes moved, Ms. Musolf seconded a SECOND READING AND ADOPTION OF ISD POLICY 6320 IN PLACE OF WEBBERVILLE POLICY 6320. Roll Call Vote: Lycos – Y; Rhodes – Y; Musolf – Y; Rockey - Y. Motion passed 4-0. Mr. Smith clarified policy change to purchase constraints.

D. Ms. Rhodes moved, Mr. Rockey seconded a MOTION TO APPROVE THE PURCHASE OF A SALT SPREADER FROM R AND A OUTDOOR SALES AND SERVICE, AS PRESENTED, NOT TO EXCEED \$10,800.00. Roll Call Vote: Lycos – Y; Rhodes – Y; Musolf – Y; Rockey - Y. Motion passed 4-0. Mr. Smith explained desired piece of equipment and costs. Ms. Musolf asked about warranties.

E. Ms. Rhodes moved, Ms. Musolf seconded a MOTION TO APPROVE THE LED LIGHTING REPLACEMENT IN THE MIDDLE SCHOOL AND SPARTAN CENTER GYMS BY LANDRY AND SONS, AS PRESENTED, NOT TO EXCEED \$23,00.00. Roll Call Vote: Lycos – Y; Rhodes – Y; Musolf – Y; Rockey - Y. Motion passed 4-0. Mr. Smith shared that replacement of the entire lighting device is required for updates and as a long term solution. The LED fixtures should last around 20 years in both gyms.

F. Mr. Rockey moved, Ms. Rhodes seconded a MOTION TO APPROVE THE UPDATED SPARTAN TIME COURSE DESCRIPTION, AS PRESENTED. Roll Call Vote: Lycos – Y; Rhodes – Y; Musolf – Y; Rockey - Y. Motion passed 4-0. Mr. Smith shared this is updating the wording of this course to ensure compliance with pupil accounting. Ms. Musolf asked if we are ensuring certified teachers are being used for instruction. Mr. Smith confirmed we are.

G. Ms. Rhodes moved, Mr. Rockey seconded a MOTION TO APPROVE THE PROPOSED NO BACKPACKS, COATS, OR BLANKETS POLICY, AS PRESENTED. Roll Call Vote: Lycos – N; Rhodes – Y; Musolf – Y; Rockey - Y. Motion Failed 3-1. Mr. Smith shared the policy may be separated per board recommendation.

H. Ms. Rhodes moved, Mr. Rockey seconded a MOTION TO APPROVE THE PROPOSED WILSON TALENT CENTER DRIVING POLICY, AS PRESENTED. Roll Call Vote: Lycos – Y;
