

**Webberville Community Schools Board of Education  
Board Work Session Meeting Minutes  
November 14, 2018**

This work session meeting of the Webberville Board of Education was called to order by President Amy Coe in the Spartan Center on Wednesday, November 14, 2018, at 6:00 PM.

**Approval of Agenda**

Mr. Hondzinski moved, Ms. Lycos seconded a motion to approve the agenda of the Board of Education Work Session being held on today's date, Wednesday, November 14, 2018, as presented. Motion passed 5-0.

**Financial**

Jon Pechette of the business office provided the monthly update for October with no unusual activity reported. Budget revisions will be forwarded for action in December or January. Projections for the end of the year are taking into account the proposals for current negotiations. Mr. Friddle shared information about a potential bond proposal and suggested a committee could be formed to review projects. Any projects with a cost over \$24,000 would need to be put out for bid. Josh Rockey has provided a quote for security systems at the elementary. To prepare for a security grant from the Michigan State Police, the emergency operation plan must be reviewed.

**Buildings and Grounds**

The board discussed the concessions building. Quotes for cabinets have been received and there was discussion about the design. Additionally, deadbolts will be installed on the doors.

**Personnel**

There may be a potential paraprofessional opening in the district.

**Other Miscellaneous**

The president moved Item XI (comments from the audience) to this position in the agenda.

### **Comments from the Audience**

Mr. Nate Lott shared his thoughts on the following topics: 1) Webberville sports should leave the Genesee Area Conference (GAC) for a different league. 2) Cross country should be made a school-supported sport. 3) He would like a buzz-in security system at the elementary school. 4) He is happy with the flooring in the Spartan Center gym and does not support replacing with a wood floor. Mr. Wes Diener echoed Mr. Lott's comments regarding the GAC.

### **Closed Session**

Ms. Lycos moved, Mr. Schriener seconded a motion to move into closed session for the purpose of a discussion on collective bargaining per Section 8(c) of the Open Meetings Act.

Motion passed 6-0. The board moved into closed session at 7:28 PM.
