

**Webberville Community Schools Board of Education  
Regular Board Meeting Minutes  
February 12, 2018**

**Call to Order**

The regular board meeting of the Webberville Board of Education was called to order by Vice President Jennifer Lycos in the Spartan Center Community Room on Monday, February 12, 2018, at approximately 6:03 PM.

Ms. Rhodes moved, Mr. Carpenter seconded a motion to approve the agenda of the regular Board of Education meeting being held on today's date, Monday, February 12, 2018, as presented. Motion passed 5-0.

This is the 10% of the 90/10 formula for funding school districts. The district will apply for a grant that is available to support full time tutoring. The formation of an achievement committee will give us an opportunity to review what we do to support our students.
