The auditors reported they found no deficiencies in internal controls, no suggestions for improvement, and issued the standard findings letter to the board. General fund revenues increased and expenditures decreased in 2018-19, allowing the district to maintain a 9.9% fund balance at the end of the fiscal year. Additionally, Mr. Staley shared information about GASB 84 and 87, the federal procurement standards issued in January 2017 and effective for 2019-20.

Mr. Friddle provided an update on the elementary roof replacement and the work to finish up the project. He believes the district is in a good position with hiring to provide solid support for students this year and will potentially will hire a couple more paraprofessionals to finish the hiring. He provided a reminder this is Homecoming week.
