Designation of Legal Counsel for 2020

Ms. Lycos moved, Ms. Barbour seconded a motion to retain Thrun Law Firm as legal counsel pertaining to school elections, bond issues, negotiations, personnel matters, and general legal assistance as needed. Motion passed 7-0.

Ms. Barbour moved, Mr. Carpenter seconded a motion to retain Steven D. Lowe, P.C. as legal counsel pertaining to employee benefit matters on an as-needed basis. Motion passed 7-0.

Delegation of Election Duties

Ms. Lycos moved, Ms. Barbour seconded a motion to allow the Secretary of the Board of Education to delegate the annual election duties to the Superintendent who will work with the appropriate township personnel. Motion passed 7-0.

Delegation of Treasurer's Duties
