Financial

Personnel

Mr. Friddle reviewed the personnel action items on Monday's agenda.

Other Miscellaneous

- Current COVID 19 numbers in the community has caused the buildings to move to 100% virtual learning for students in all grades, with an expected return of March 22. While there was a small number of positive individuals in the buildings, the number of those that must quarantine due to exposure was approximately 110.
- Mr. Smith presented information on the proposed cooperative agreement with Dansville Schools to field a varsity baseball team. He also provided an update on the quarantine periods for the sports teams.
- Staff is working on the 2021-22 secondary master schedule, which will have a six-period day.
- The business office is researching bond refinancing for a potential savings on the 2012 bond.

- The website is being upgraded and a new look will be rolled out by the end of the school year.
- Senior activities are being planned and, weather permitting, graduation will be on the football field.
