The group discussed a transition to provide more face-to-face instruction for the remainder of the school year. The needs vary greatly across grade levels and classrooms, and consideration will be given to keep instruction the same for virtual students and face-to-face students. Upon return to the buildings staff will identify academic, social, emotional and mental health needs. A component of Google Classroom will be maintained as a mechanism if classes are forced to go virtual in the future. It is important to keep kids safe, engaged, and on-track for the future.
