- A van has been located for purchase for special education transport
- The track repair was discussed

- Additional spray patching is necessary in the lots and an action item to approve additional funds will be on the agenda on Monday
- It was suggested that additional arrows be painted in the lots to direct traffic
- Gutter work will be done on the barn and back of the secondary building
- New postings for coach positions will be out soon
- Hourly staff have been collecting money at athletic events in lieu of requiring parents to provide work and pay working deposits
- Social worker will be attending a conference and the requirement of a mentor will make it necessary to pay someone outside the district
- The WEA has requested that the two days before Christmas be changed to half days for exams rather than the full days on the schedule
- A digital sign on Grand River in front of the secondary will cost around \$40,000 and will explore fundraising opportunities to pay for the sign
